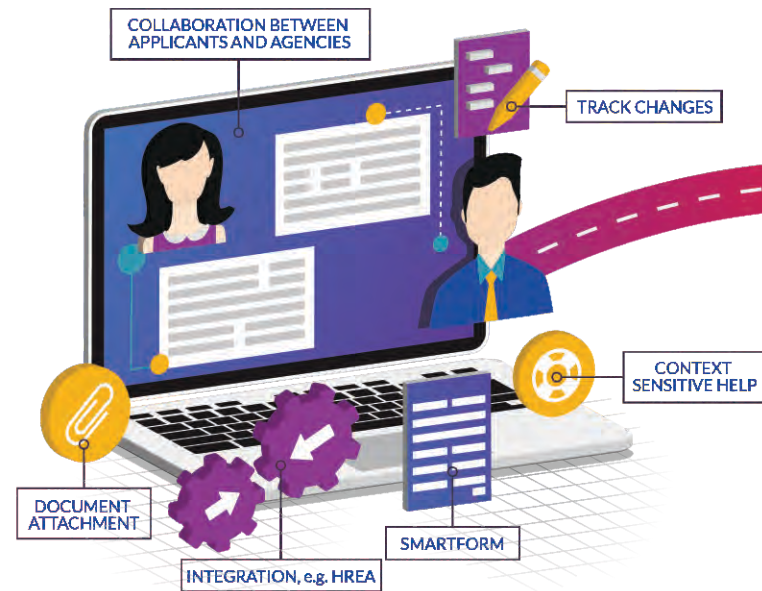

# RESEARCH MANAGEMENT ETHICS AND GRANTS

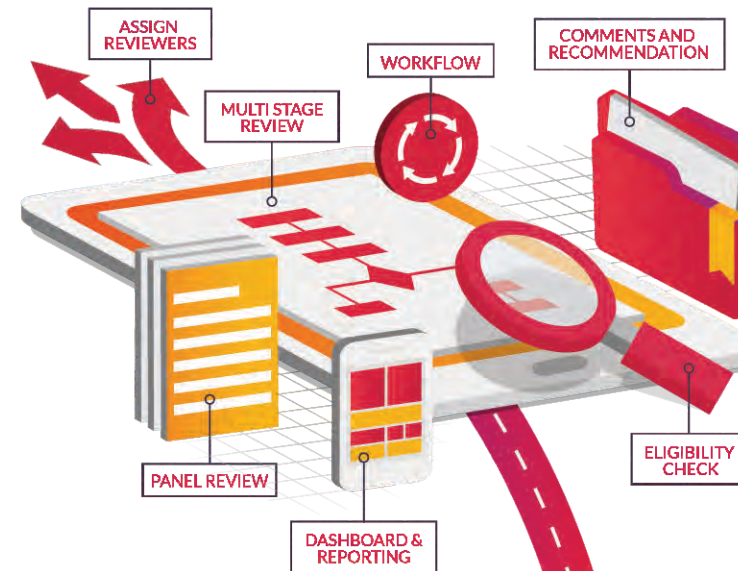
## 1/ SUBMISSION

- // Applicants can register and get started on a new research or grants application in seconds.

## 2/ REVIEW

- // Decisions are registered with the full detail of all reviews ensuring informed decision making.



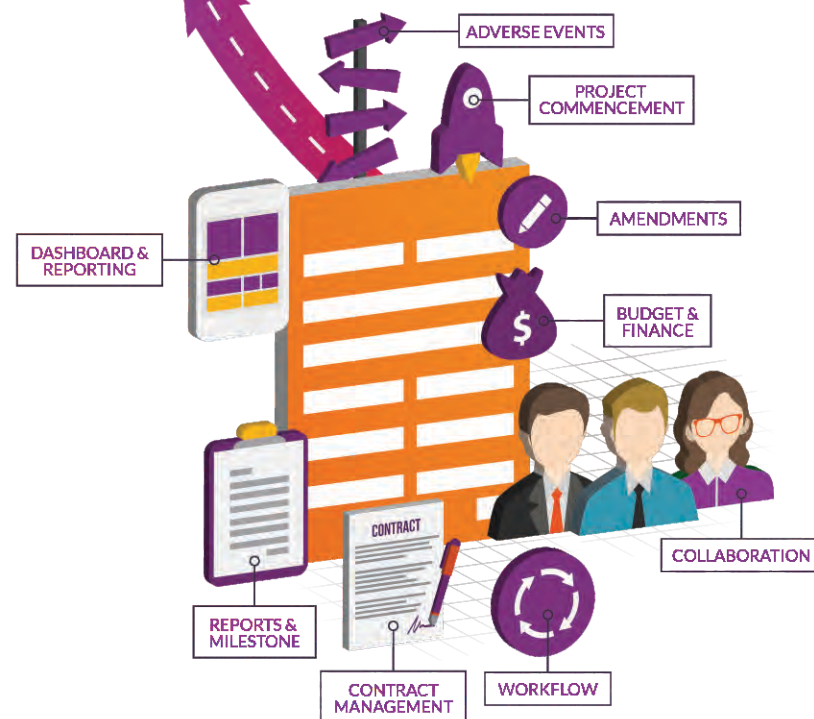
## 3/ DECISION

- // User configurable status and workflow to facilitate any level of decision process complexity.



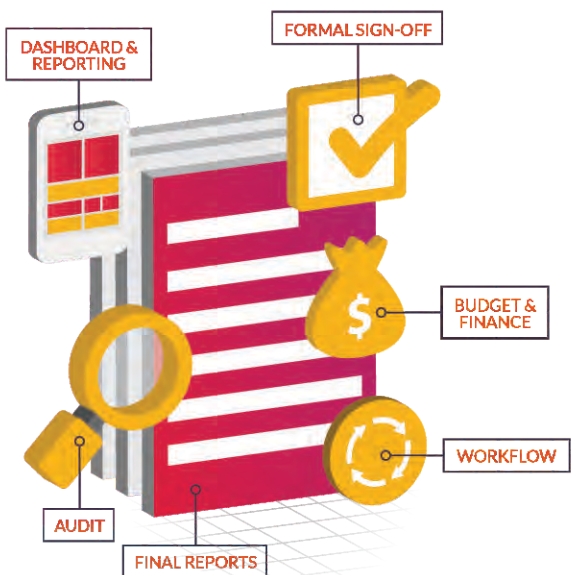
## 4/ EXECUTION
